She is also a Clinical Professor with the University of California, San Francisco School of Pharmacy and the UC Davis School of Medicine. She is the Director of the PGY2 Oncology Pharmacy Specialty Residency at UCDMC.

Andrea completed her Doctor of Pharmacy degree in 1992 at the University of California in San Francisco. She also completed her Pharmacy Practice Residency at UCSF in 1993 and an Oncology Pharmacy Specialty Residency at MD Anderson Cancer Center in 1994. Andrea is a Board Certified Oncology Pharmacist and an appointed, Specialist Member of the Board of Directors, for the Board of Pharmacy Specialties (BPS). Andrea has previously served as an appointed member, vice chair and chair of the Oncology Specialty Council of the BPS from 2002-2007.

Andrea is a regular reviewer for the Journal of Oncology Pharmacy Practice and has co-authored several articles and book chapters on a variety of oncology topics. Dr. Ty Kiser is a Tenured Professor and Vice Chair in the Department of Clinical Pharmacy at the University of Colorado Skaggs School of Pharmacy and Pharmaceutical Sciences. He is a Clinical Pharmacy Specialist in the Medical Intensive Care Unit at the University of Colorado Hospital.

Dr. Kiser received his Pharm.D. at the University of North Carolina. He completed a pharmacy practice residency at Johns Hopkins Hospital and a Critical Care Residency and Critical Care/Infectious Diseases Fellowship at the University of Colorado.

Dr. Kiser served as the chair of the Society of Critical Care Medicine Clinical Pharmacy and Pharmacology section and as chair of the American College of Clinical Pharmacy (ACCP) critical care practice and research network. He previously served on the board of regents for ACCP and the critical care specialty council for the Board of Pharmaceutical Specialties (BPS).

Dr. Kiser's research has focused on optimizing the pharmacokinetics and pharmacodynamics of pharmacologic agents in critically ill patients with organ dysfunction and has resulted in over 150 peer reviewed publications. He has been a speaker over 75 times at national and international conferences and has directly trained over 25 PGY2 critical care residents.

Dr. Tovar recently joined the Philadelphia College of Osteopathic Medicine - Georgia Campus. He serves as Associate Professor and Chair for the Department of Pharmacy Practice. Dr. Tovar has presented at numerous national and international meetings. Dr. Tovar's areas of research interest include cardiovascular and infectious diseases. More recently, Dr. Tovar has begun researching teaching methodologies used in the education of pharmacists. He is also a passionate advocate for immunizations.
